Scheduled Benefit:

*Each eligible employee may elect for himself and/or his eligible spouse an amount of insurance shown in the Table below.

For employees age 75 and older:

*Benefit Amounts are reduced according to the age-based reduction chart shown on the Voluntary Term Life sheet. When selecting an amount of insurance, you must select a pre-age 75 benefit amount.

To find you and your spouse's premium:

*Determine your age band: Your age = your last birthday.

*Select a benefit amount (employees ages 75 and older see above comment - do not select a calculated reduced amount)

*Spouse Premium: Repeat the steps above for your spouse at his/her age at her/her last birthday. (spouse must be under age 70 to be enrolled)

*Employee and spouse rates change as insured moves from one age bracket to the next.
